State Reports

<u>Alaska</u>: carolyn Brown reported that her state maintained Rank-Choice Voting despite an effort from its legislature to eliminate it.

<u>California</u>: Hank Abrons shared the <u>link to the video</u> (passcode X6FEj@=p) about nursing homes in California. Jon Li shared the establishment of US Community Healthcare.Net focusing on local public health departments.

Georgia: Sharon Hill, LWVGA VP of Advocacy, says that to maximize advocacy, her League has partnered with other organizations like <u>NAMI</u>, making inroads w/Medicaid Expansion & Healthy Families (work on <u>Paid Family Leave</u>). They plan to lean in on local, municipal issues in 2025, as a bridge to federal midterms.

New York: Judy Esterquest reports that her local League and others have adopted a *short version of the Vermont privatization position* and hope that the state League will adopt it by concurrence in June. A topic for the December HCR4US meeting?

<u>Virginia</u>: Stephanie Lowenhaupt reports that VA is preparing for its short legislative session and a governor's race. They are also advocating for 3 constitutional amendments, (including a reproductive rights amendment) and lots of state issues.
