## January Meeting Topics

### Exploring Action-oriented Advocacy

At our Jan. 26 meeting, the most glaring issue for health care advocates was the nomination of the inappropriate, anti-science RFK Jr. to head the office of Health and Human Services (HHS), a position offered to him as a political favor.

What can we as League members do, we asked each other, to oppose his confirmation? **Does LWV non-partisan policy apply to political appointees as well as candidates for office?** A [quick email](#) with LWVUS Gov't Affairs confirmed, yes, it does apply.

If only there were an "[Action Alert](#)" like the one in the LWV President's [2-6-2025 "League Update"](#)! It says "Tell Your Members of Congress (and your networks) to Oppose the *SAVE Act*."

Without a relevant alert, could we use other official statements from LWVUS leadership, that include a request to share them, to fashion an "**alternative action alert**" that would let us communicate with our Members of Congress on this issue? Perhaps something like this:

Dear MOC,

*I am writing to share LWV CEO Celina Stewart's [strong condemnation](#) of the "weaponization of government against Americans,...that puts both [the American people and our democracy] in deep jeopardy. ...[LWV] calls on Congress to act now to stop the infringement on its legislative authority and respond to the ongoing assault on our democracy on behalf of the American people."*

*Personally, I am deeply concerned that the nation's health and safety could be at risk if HHS is weaponized by leaders with attitudes hostile to well-established science in the field. As your constituent, I urge you to use your legislative authority to ensure that the next head of the HHS will commit to robust distribution of life-saving vaccines, collection of data on which to base policy relative to food safety, drugs, etc., and will maintain our membership and support of international health agencies."*

What do you think? Is it within LWV guardrails? Could a League member send it?

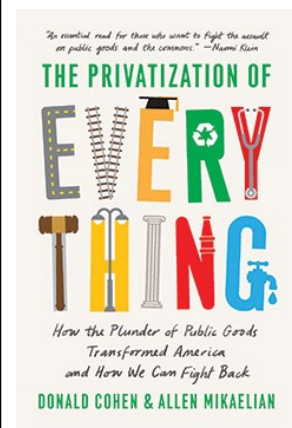
### Invitation to a Book Discussion

#### [The Privatization of Everything: How the Plunder of Public Goods Transformed America and How We can Fight Back](#)

HCR4US members who worked on the concurrence with Vermont's new privatization position know the importance of this topic in health care — as it has been in a range of other areas, like jails, parking, roads, etc. The failure to adopt the VT concurrence at the 2024 convention was due perhaps to a prevailing sense among many Americans, including League members, that "corporations achieve superior efficiencies" and save us money. This book provides example after example to lay that myth to rest.

For governments, the appeal of "public-private partnerships," where private companies front money for public infrastructure, is the promise that they can get improvements with "no new taxes." However, the private investment usurps control of public goods and services and sends public money to contractor profits and investor returns. The true result, well-documented in this book, is reduced services and higher fees for users and lower wages and fewer protections for workers.

## Revisiting the Mission Statement

Does our Mission Statement (*MS, top of page 1*) capture our goals clearly enough to let us decide which activities will be consistent with them and which won't?

To help us decide whether we need to change either our statement or our activities, **Hank Abrons (CA)** framed these questions for us:

*What impact do we hope to have? Why do we meet? What is it we're trying to do in the League that can benefit from us working together?* Others added: *Does being in the League help us achieve our goals for health care reform?*

A Zoom poll at the Jan. 26 meeting asked attendees to consider whether we will have more impact if (1) we follow the prominent mention of Single Payer in the MS, and keep a narrow focus on achieving Single Payer financing reform; *or* (2) follow the first phrase, "work to educate and mobilize League members," and cast a wider net to harness energy among state and local Leagues for more varied health care reform topics; *or* (3) do both.

With only 15 voters, and some internal inconsistency, the slight advantage for a wider net in the polling is not a mandate. Still, can the poll help us clarify our desired impact and evaluate case by case whether an activity is enhanced by our being in this special interest group of the League -- or not?

For example, what do our different interpretations of our Mission Statement mean for the activities that were suggested at this meeting?

1. Work with groups like [Indivisible](#) to show public resistance
2. Follow up with Alan & Voki's [Daily Advocacy Newsletter](#)
3. Work on building up our state networks
- 4 Pursue useful incremental steps at the state level (*Medicaid eligibility for the undocumented, negotiation of drug prices, improved maternal health, state restrictions on private equity ownership of healthcare facilities, elimination of Pharmacy Benefit Managers, Medicare Advantage, and so-called "Value Based Care"*)

Numbers 1 and 2 are not consistent with policy [guidelines for taking action](#) as a League member. Numbers 3 and 4 are ambiguous between a narrow or wider mission.

Could we work as a group on activities like 3 and 4 and commit to Categories 1 and 2 as individuals, but still share what we learn from them with each other and the general public, perhaps even with LWVUS leadership.
