Vax versus anti-vax: Individual and population perspectives

Partisan polarization infects health care with the same rancor seen in political discussions around matters like taxes and immigration. It makes what should be a core truth (all people should have access to health care) into

a partisan topic. During the COVID pandemic, rejection of the novel vaccines and precautions like masks split largely along party lines. Now, the rejection of the measles vaccine, currently in the spotlight because of unprecedented outbreaks of the very contagious virus, is found among both conservatives and progressives.

Secretary of HHS RFKJr's distrust of vaccines is wellknown. Less expected is fervent support for his campaign to "Make America Healthy Again" from the socalled "MAHA Moms." Physician and columnist Leana Wen was unnerved that there were mothers--a category she herself belongs to - who actively reject measles vaccine, thus posing a health threat at both the individual and population levels. To gain insight into MAHA Moms' motivations, Wen visited their online forums, probed the social media of "momfluencers," and conducted dozens of interviews.

Two of the subgroups she identified occupy opposite ends of the political spectrum. As expected, religious conservatives were concerned with their "medical freedom" and were distrustful of government in general, saying, for example, "the perils of infectious diseases are overblown," and "vaccine injury is not being taken seriously." By contrast, Wen also found a subgroup of left-leaning "crunchy" moms who ---like herself -favor organic, unprocessed food, and aggressively avoid toxic chemicals in toys and cleaning products. They pride themselves on doing their own research and prefer more natural ways to build immunity than vaccines.

Protective Cognition" described by Yale law professor J. Kahan in "Politics Makes Us Stupid." (See our Sept 2023 newsletter.) It is adaptive, he claims, for us to resist factual information that threatens our sense of

> He and his colleagues showed experimentally that people who interpreted data accurately in a low-stakes argument — in their example, evaluating the effect of a skin cream — rejected interpretations of data if they threatened their core values

and/or membership in their "tribe." Wen found both conservatives and progressives among MAHA moms with core values that led them to override the facts, like those in graph, based on years of data collection.

From a health perspective for an individual child, the comparison of adverse events from measles vaccine compared to having the disease strongly favors vaccine. The tiny black square and tinier dot in the right box show that "vaccine injury" is technically zero: 3 in 10,000 cases of seizures, and many fewer cases of abnormal blood clotting, or allergic reactions. The red interlocking boxes on the left show a statistical probability of 3 in 100 expected serious complications such as encephalitis, loss of hearing, pneumonia, or other hospitalizations (including 3 deaths in a thousand) from getting measles.

This calculation of measles side-effects completely ignores the public-health benefits of the vaccine — the elimination of the threat to the general public that national vaccination rates over 90% achieved in the U.S. by 2000, with the last death in 2003. Public health decisions are not made on an individual basis. As international comparisons by Chinhuei Chi show, they represent a collective desire for a just society, antithetical to the anti-vax movement.

As a group, the "MAHA Moms" exemplify "Identity



Braver Angels Seeking a path out of our "bubbles"

Progressives and conservatives in the U.S. (the "libtards" and "magats") experience intense mutual disrespect in public discourse on a daily basis. Research by the Pew Charitable Trust confirms that the polarization underlying this overt antagonism became more pronounced after the 2016 election, and is now further sharpened by our entrenched two-party system. At the policy level, parties exploit "closed" primaries where they need very few votes to weed out opposing viewpointss. In 2024, for example, <u>87% of our Congress</u>, was elected by 7% of eligible voters, on average, who show up for primaries conducted within party lines (as opposed to "open"). In this way, a small minority of zealots have voted in unpopular policies that have many fierce enemies.

At the personal level, the resulting <u>differences between sides</u> seem so wide and discussion so acrimonious that many families found they could no longer even celebrate holidays together, cutting people off from those they loved.

To create a basis for greater understanding and empathy across the divide, <u>two friends got together</u> and came up with a formula for bringing together people who had voted for different candidates. It has since developed into a nationwide organization. Harking back to Lincoln's "Better Angels of our Nature," **Braver Angels** creates a <u>safe space for moderated discussions</u> of issues where deep listening and respectful speech are enforced. <u>People use their turns</u>, not in order to change the others' minds, but to explain why they hold the opinions they do. The listener refrains from challenging the speaker directly. Both sides are looking for pockets of common ground.

Today, Braver Angels offers a constant flow of in-person and virtual <u>workshops</u>, <u>debates</u>, <u>and other events</u> following their principles. In many communities, their programming is the only venue where "red-leaning and "blue-leaning" people are in the same spaces, a necessary step for finding a path across the divide.

Since it's explicitly not a goal, it is rare for people to change their minds at Braver Angels events which leads many people to experience the sessions as frustrating and unsettling. Still, it does appear to lower the volume and dial back the name-calling to a point where opponents might find common ground. Do you know of other alternatives to staying in our "bubbles," moving further apart?
