LWV National Interest Groups Explore Topics to Tackle Together

LWV national Interest Groups, Health Care Reform and Immigration, have organized a joint webinar in search of a potential joint action. We've been looking at healthcare through an immigration lens and immigration through a health care lens. Fortunately, both perspectives have

materials to help us prepare to cross disciplinary lines, such as dedicated units within trusted information sources like [KFF](#) and [National Immigration Law Center \(NILC\)](#) among others, that work at the intersection of our topics.

Both areas are currently at high URGENCY — across the country and within the [Action framework](#) of the League — fomented by narratives of immigrants as criminals running amok and them using health care resources [at the expense of "real" Americans](#). Such beliefs ignore solid evidence against them:

1. Immigrants are [less likely](#) than native born Americans to commit criminal acts.
2. Immigrants, including the "undocumented," are net contributors to public healthcare resources: they work and pay taxes that support programs they are barred from accessing, [thus paying for others' care](#).

In immigration, urgency is kept elevated by the criminalizing innocent people, who can become criminals without making a move. One strategy is to decree sudden policy changes that [remove protected status](#) or [revoke visas](#) with a single signature. As the story goes, if you are protecting the public from the "the worst of

the worst," you must defend yourself from their violence, and so arrests take on the look and feel of [ongoing SWAT raids](#). However, DHS's own data tell us that at most [8%](#) of people in their custody have been convicted of violent

crimes. Most detainees have either no charges against them or they have [civil infractions](#), often decades old, that normally carry fines or lost privileges as remedies. But now, both civil and criminal are in the same dragnet. Hard data show that at least 1 in 2, maybe 3 in 4, immigration arrests are unjustified, so citizens began [organizing into rapid response networks](#) to protect neighbors from unwarranted arrest. These allies are now being [labeled "domestic terrorists"](#) and are also subject to violent assault.

In **healthcare**, misguided responses to imagined dangers from immigrants carry less firepower, but are no less tragic. Beyond the death toll and suffering of those swept up in the violence, children especially will suffer lasting [effects of the collective trauma](#). [Cutting out 20%](#) of our healthcare workforce, [from orderlies to physicians](#), compounds the collateral damage.

So, what projects do the combined lenses of our two fields suggest? Come help us open the conversation to envision what we might accomplish — individually and together — to Defend our Democracy and heal our communities. *Submitted by Barbara Pearson*
